**FRESH APPLICANTS** should bring the following documents (in original and photocopies)

- Printed copy of filled up SVMCM form
- Admit Card of Madhyamik or equivalent examination
- Marksheets of Madhyamik or equivalent examination (**both sides**)
- Marksheets of Higher Secondary or equivalent examination (**both sides**)
- Income certificate issued by **competent authority** as mentioned below / in the website
- The first page of your bank passbook that clearly mentions your account number and IFSC details
- Domicile certificate as **Aadhaar ID/Voter ID/Ration card/Certificate** Issued by concerned authority
- Admission receipt of the current semester (**SEMESTER-1**)
- Documents/Declaration regarding not applying for SVMCM in previous years (Option will appear only if applicant selects Year of Qualifying Exam as 2024 and 2023 while registration)

**NB:** Income certificate **must** be issued by the **Competent Authority** (BDO/SDO/Jt. BDO / BLRO (Panchayat Area), Executive Officer / Finance Officer / Education Officer in case of municipality, Commissioner / Dy. Com / Municipal secretary in case of Corporation Area, G.R-A Gazetted Officer).
